## Amesbury Elementary School – Statement of Interest

On Tuesday afternoon, Mayor Gray, Assistant Superintendent Deirdre Farrell, AES PrincipL Walter Hellieson, Amesbury Facilities Norm Fredette and I met with senior staff members from the Massachusetts School Building Authority to discuss our submission of the statement of interest to MSBA for the funding of improvements/additions to the Amesbury Elementary School. Late last winter, we submitted the statement of interest on behalf of the Amesbury Public Schools. In total, 97 SOIs from across the state were submitted for consideration. MSBA conducted an initial review of the submissions through the lens of need and urgency. From the initial submission, MSBA selected approximately 35-40 applications for further review. As part of this secondary review, MSBA scheduled visits at each of the schools to spend time further exploring our submission, clarifying aspects of our submission, as well as taking the opportunity to tour the facilities to understand the complexities of how our building issues can impact student learning. I want to compliment our Amesbury team for their detailed articulation of the needs of the building. I believe a strong case was made for needed improvements at Amesbury Elementary. Official notification to schools moving forward in the process will be made by the MSBA board at their meeting in the end of January 2016.
