Recorded - DECEMBER 15, 2009 - as Amended 1/5/10

Present at 7:00 p.m. were Thatcher Kezer, Chair, Tom McGee, Gale Hanshaw, Bonnie Schultz, Debra Bibeau, Stanley Schwartz, David Jack, Superintendent of Schools and Chanelle Havey, SAC Representative. Absent: Paula Blair

The Chair called the meeting to order. Bonnie Schultz led the Committee in the Pledge of Allegiance.

2. PRESENTATIONS

A. Student Advisory Council Discussion with School Committee

The Student Advisory Council was present discussing areas of concern.

- First they all introduced themselves and stated what grade they were in.
- Chanelle Havey, SAC Representative, discussed with the committee that all of the schools had different policies regarding electronic devices. She stated that MP3 players and IPods were allowed at the high school and that cell phones could be on during lunch but not used.
- Discussion about having on Open House for alumni during a Friday night basketball game. Dates in January were given depending on the sports schedule.
- Steve Hanshaw, Vice President of SAC, spoke about the problems with the Nutrikid payment plan at the high school, that the lines were too long and the students did not have time to eat their meals. Discussion about the issue was made. Mr. Jack will speak to Mr. Kish, Food Service Director, about the problems at the high school. SAC will encourage students to use the pre-pay which will make the lines move quicker.

B. Solar Panel Grant for AHS - Kendra Amaral, Mayors Office

Kendra Amaral, Chief of Staff for the Mayor, made a presentation to the committee regarding a Solar Block Grant application that has been submitted. If awarded, a solar panel array would be placed on the cafeteria roof at the high school. A decision will be made in mid February whether or not the grant would be awarded to APS. Ms. Amaral stated that if this grant comes thru, it could be joined with other grants to go 'Green'. A vote was needed by the School Committee to get the solar panels if awarded.

Motion by Stan Schwartz, seconded by Deb Bibeau, to receive the solar panels if the grant was awarded to APS. Unanimous, Yes, Student rep, Yes.

C. Energy audit Walkthrough and Reports - Michael Bergeron

Michael Bergeron, Business Administrator, presented the committee with a power point regarding the initial findings and recommendation of his energy audit of the schools. The focus of his study was categorized in three areas:

- 1. Data Management (collecting and analysis of the data);
- 2. Supply Side Management (who are the suppliers and what rates are they offering);
- 3. Demand Side Management (our daily use and how effective is it to the budget).

Mr. Bergeron concluded his report stating the importance of all staff in the APS to work together to save energy. He feels that with everyone working together, there would be a 3-5% savings.

3. COMMENTS BY VISITORS, DELEGATIONS

Greg Noyes spoke regarding MCAS math scores at the elementary school. He would like
to see Ms. Leary, K-12 Math Director, analyze why Amesbury Elementary School
MCAS math scores are so low and bring her finding back to the committee. Mr. Noyes
also stated that he appreciated the Energy and Solar panel reports made by Kendra and
Mike but would like to see it in context.

4. <u>ADMINISTRATIVE REPORTS</u>

A. Curriculum Director's Report

1. EPIMS Summary - Telena Imel

Telena Imel updated the Committee with a power point presentation about the EPIMS report for the state that replaces the DSSR report. This report is a snapshot of the October 1st report on all the staff in the school system except for the cafeteria workers, bus drivers, maintenance and custodian. She went on to state that all teachers must be licensed for the position that they were hired to teach.

B. Superintendent's Report

1. Race to the Top Funding Update

Mr. Jack updated the committee on the latest status of the RTTT Funding. He stated that the timeline of January 13th is very tight for signatures needed by the union, mayor and superintendent. There are pieces of this funding that are advantages to Amesbury depending on the requirements that would be set. Information is slow coming and not clear. He will continue to monitor the information and keep the committee informed.

2. Other

Mr. Jack spoke about the MCAS & Growth model. Since the AES and AMS were identified as schools needing improvement, the Department of Education will help to put them in place to move forward with their scores. The administrators will be offered some training for this in mid January.
